1. **St. Bernard "Voluntourism" - Working with the St. Bernard Project**
REGISTRATION FOR THIS EVENT IS NOW CLOSED. The St. Bernard Project is a rebuilding organization with opportunities for both skilled and unskilled volunteers. During your time with the Project, you could be doing any of the following tasks: installing exterior doors and windows, installing insulation, hanging sheetrock/drywall, taping sheetrock joints, mud/spackling, putting down flooring, installing interior door, trim and cabinets, yard work and painting. **IMLA Conference Attendees can have a chance to participate with this Project on Saturday, October 9th.** You will participate in orientation and get a work assignment with directions to your worksite. If you, or anyone in your group, is under 18, please have a parent or guardian sign the liability waiver either here or ahead of time if they will be unaccompanied. The Project must receive a waiver from each volunteer.
